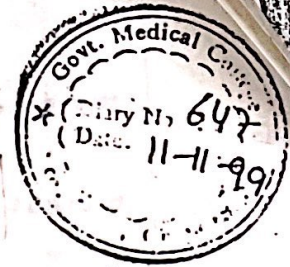
Reference this Administration's Memo. No. 6799-

2. The Punjab Government vide their letter No. 12/55/93-  
5H5/19871, dated the 10th September, 1996 followed by letter  
No. 12/55/93-5H5/1303, dated 16th January, 1997 and No. 12/55/93-  
5H5/11941, dated 5th May, 1997 (copies enclosed) have delegated  
the powers to the concerned Administrative Secretaries/Heads of  
Departments/Offices to sanction the reimbursement of Medical  
Charges under the provisions of Punjab Services (Medical Attendance)  
Rules, 1940. Therefore, it has been decided by the Chandigarh  
Administration to adopt the aforementioned letters of Punjab  
Government in the Union Territory, Chandigarh and financial powers  
to sanction these claims under the aforementioned rules are hereby  
revised as under :-

<u>S. No.</u>	<u>Authority</u>	<u>Amount of Claim</u>
1.	Head of Office	upto Rs. 1200/-
2.	Head of Department	From Rs. 1201 to Rs. 10,000/-
3.	Administrative Secretary	From Rs. 10,001 and above.
