I am directed to invite your kind attention towards Government Letter no. 12/23/2003-5HBV-13195 dated vide which Punjab Government has framed the medical reimbursement policy for Punjab Government employees/Pensioners.

2. The Government has considered the matter regarding the reimbursement of medical bills of Punjab Government employees/Pensioners and their dependents who have subscribed to medical insurance policies on their own and thus are eligible for reimbursement by the Insurance companies. It has been decided with the approval of the competent authority that the reimbursement of medical expenditure from both the sources, namely insurance agencies and Government, may be claimed, subject to the condition that employees/Pensioners will first claim insurance from insurance company and there after submit the medical bills to the Government, which will reimburse the difference between the total amount of the bills and the payment made by the insurance company, with condition that the payment done by the Government will not exceed the admissible amount as per Government rates
