### PhD admission Notice (Full Time Only) for 2025-26

(Under Visvesvaraya PhD scheme for Electronics and IT: Phase-II)

PEC proudly announces that the Institute has been selected as one of the Centre for prestigious Visvesvaraya PhD Scheme for Electronics and IT: Phase-II supported by Ministry of Electronics & Information Technology (Meity), Govt. of India. **Total number of available fellowships are 02 for Dept. of Electronics & Communication Engineering (including 01 under C2S Project of MeitY).** Post Graduate students in relevant fields of Engineering/ Technology who are interested in pursuing research in relevant areas may apply for admission to a full time PhD program with fellowship under Visvesvaraya PhD scheme for Electronics and IT: Phase-II for 2025-26.

Applications are invited from eligible candidates for admission to PhD programme on Full Time basis for Academic Session 2025-26 in the Department of Electronics & Communication Engineering **(02 nos. including 01 no. under C2S Project of MeitY)** under the **Visvesvaraya PhD Scheme for Electronics and IT: Phase- II**. A consistently good academic career will be preferred and selection will be made on the basis of overall academics, entrance test for Non-GATE/ Non-UGC NET candidates and interview performance. **Candidates having GATE/ UGC NET (any category) are exempted from the entrance test.** The interested candidates can submit the application form along with relevant enclosures as per guidelines available on website of Institute. The candidates are required to pay non-refundable fee (online) of Rs. 1000/- for General and Other Categories, Rs. 500/- for SC/ST.

**The major features of the scheme for the full-time scholars are given below:**

**Fellowship:** Rs. 38,750/- per month in 1<sup>st</sup> and 2<sup>nd</sup> year and @Rs. 43,750 per month in 3<sup>rd</sup>, 4<sup>th</sup> and 5<sup>th</sup> years of PhD (support till PhD completion or 5 years whichever is earlier)

**Reimbursement of Rent (RoR):** This component is linked with the fellowship of PhD Candidate. The rate of RoR is 24%, 16% & 8% (of fellowship) for X, Y & Z class cities/towns respectively. The classification of the cities is as per the notification issued by the Ministry of Finance for the reimbursement of HRA.

**Research contingency Grant Support:** An amount of Rs. 1,20,000/Year for Full-time PhD candidate.

**Support for attending International conferences:** Support upto Rs. 1.5 lakhs/Full- time PhD candidate.

**Visit to Labs abroad:** A support for each selected Full-Time PhD candidate upto Rs.10.5 lakhs for visit to labs abroad.

**Eligibility Criteria Essential:**

Master's Degree with Bachelor's in Engineering/Technology/Sciences with First Class or 60% marks (55% marks for SC/ST/PwD)/CPI or CGPA greater than 6.5 (6 for SC /ST/ PwD) on a 10-point scale.

6. Candidates are required to write his/her name and contact number on the UPI/NEFT/RTGS Receipt.
7. The Application Fee is non-refundable.
8. The envelope containing the Application Form shall mention on the top in bold **“Application for PhD Programme Under Visvesvaraya PhD Scheme: Phase-II”** with the candidate's name, address and phone number written on it.
9. No TA/DA and/or Lodging/Boarding will be paid for attending the Entrance Test / Interview, no accommodation shall be provided.
10. Any corrigendum /changes /updates shall be made available only on the Institute's Website viz. <https://pec.ac.in/>. The candidates are advised to visit the Institute's Website regularly for any information/updates on the PhD Admission Process.

#### **Selection Process for Admission**

1. **Candidates having GATE/ UGC NET (any category) are exempted from the entrance test.**
2. For all other candidates an entrance test will be conducted for admission under Visvesvaraya PhD scheme.
3. The PhD Admissions shall be based on offline **Entrance Test and Offline Interview**.
  - a. Entrance test will be a multiple choice test; each question will have four options with only one correct answer.
  - b. The entrance test will carry 90 marks and it will have two parts, Part A of 30 marks and Part B of 60 marks. Qualifying marks in the entrance test will be overall 50%.
  - c. Part A will have 30 questions of 1 mark each on Research Methodology. It will be common to all the students and its duration will be 30 minutes.

- d. Part B will be stream/ discipline specific and it will have 60 questions of 1 mark each. Its duration will be 60 minutes.
- e. Candidates who have secured 50% marks in the entrance test are eligible to be called for interview.
- f. A relaxation of 5% marks will be allowed in the entrance examination for the candidates belonging to SC/ST/differently-abled category.

Original Documents and ID Proof would have to be produced during the documentation verification Process to be undertaken on the date of Interview failing which the Candidate may not be allowed to appear for the Selection Process.
