- vii. I do not owe anything to any other mess/hostel of PEC.
- viii. I will pay my mess/hostel dues regularly and well within the stipulated time period.
- ix. I will keep the room and furniture, etc., intact throughout my stay in the hostel and will hand over the same in proper condition to the hostel authority. I will be responsible for any breakage and loss of the room and its furniture.
- x. I will observe proper decorum and discipline in the hostel, mess and club.
- xi. I will not consume any intoxicants (liquor, cigarette, drugs or any other similar things) in the hostel premises.
- xii. I will not install room cooler, air conditioner, etc., in my room.
- xiii. I will not use electric kettle, room heater, water immersion rod, etc., in the room.
- xiv. I will reside in the allotted room and will not make mutual interchange of the room with fellow hostellers.
- xv. I understand that the room is allotted either only for the current academic session or up to **30th June** of the academic session, whichever is earlier. I will vacate the room accordingly in time.
- xvi. I shall keep my room locked whenever I go out, even for a short duration. In case of theft due to my negligence, I shall be responsible for the same.
- xvii. I understand that for any violation of hostel/mess rules or any other rules formulated and implemented by the authorities and/or Student Affairs Committee, disciplinary action and/or fine may be imposed. Further, my parents will be informed/called at any time in the hostel.
