(Applicability of Unified Pension Scheme (UPS) for the Employees of Autonomous Bodies (Abs))

- 1. Pursuant to Finance Department (Finance Branch), Chandigarh Administration Letter No. 65/1/142-UTFII (12)2025/7393, dated 15 May 2025, the Institute Vide ION No. PEC/E2/UPS/25/2773, dated 16 June 2025 asked all faculty/employees to exercise option for Unified Pension Scheme (**UPS**), who were earlier covered under the NPS.
- 2. Now Chandigarh Administration (Finance Department) vide their letter No. 65/1/42-UTFII (12)-2025/14405 dated 09 September 2025 (copy attached for ref) informed that the scheme is not applicable to the employees of Autonomous Bodies, since as on date, they are not included under the UPS.
- 3. In view of the above, the Circular issued vide No. PEC/E2/UPS/25/2773, dated 16 June 2025 may be treated as cancelled and withdrawn.

The undersigned is directed to refer to Ministry of Labour and Employment O.M. No. G-17011/01/2022-Fin.II dated 30.05.2025 seeking clarification on applicability of Unified Pension Scheme (UPS) on the employees of Central Autonomous Bodies.

2. The matter has been considered in the Department. It is informed that Government, vide notification dated 24.01.2025, has introduced the Unified Pension scheme, as an option under the NPS, for the employees of the Central Government who are covered under the NPS. As on date, the employees of Autonomous bodies are not included under the Unified Pension Schame.
