- 3 The selection would be made by the committee on the basis of interaction with the applicants and his/her experience.
- 4 The date for interaction will be intimated separately.
- 5 The envelope containing name of the applicant/ name of the firm must be super scribed with the subject on the top of outer envelope.
- 6 The application can be rejected by the competent authority without assigning any reason.
- 7 The committee reserves the right to verify the particulars furnished by the applicant. If any, information is found incorrect the application is liable to be rejected.
- 8 Conditional applications shall not be entertained
- In case of date of receiving of application/ date of interaction, declares/happens to be public holiday application/ date of interaction shall be on next working day.
