- Bidder should reach before 10.00 am in the workshop foreman's office to mark their attendance. No bidder will be entertained after the attendance. The registration timing shall be at 10.00 AM to 10.30 AM and the auction will be start at 10.45 am.
- 2. Only bidder having PAN number are eligible for participation in the bid, a self attested photo copy of PAN is to be submitted at the time of attendance.
- 3. Bid Security of Rs.20,000/- (twenty thousand) must be deposited before the auction in shape of cash or Demand Draft in the favour of Director, PEC University of Technology, Chandigarh. The bid security of the unsuccessful bidder will be refunded after the auction process is over. However the bid security of successful bidder will be adjusted in whole bid amount.

The whole amount of the highest bid + TCS 1% + VAT@6% or as applicable, for approx. 4500kg weight has to be deposited by the highest bidder immediately after auction in the shape of Demand Draft in the favour of Director, PEC University of Technology, Chandigarh or money transfer by RTGS in PEC account, in addition to bid security deposited. After receiving the payment, the bidder will be allowed to load the scrap in the vehicle.
