PECFEST Infrastructure Tender 2019

Overall summation of logistics required for PECFEST 2019, valid for all 3 days unless specified otherwise. Most of the requirements needed would vary and the bill would be charged accordingly.

(II) ELIGIBILITY CRITERIA:

a) Technical Bid (Upload Annexure-I along with this duly signed & stamped):

1. The bidder must be a legally registered company in India as per the Companies Act of 1956/ partnership firm/ proprietary firm with office and operations in India and will upload the Registration Certificate.
2. The bidder should have minimum annual turnover of Rs- 40 lacs in each of the last two financial years i.e.(2016-17 and 2017-18) and financial statement shall be uploaded as proof.

3. The bidder shall submit copies of Income tax return of last two financial years i.e. (2017-18 and 2018-19).
4. The bidder should have satisfactory completed at least one similar nature of event (as per stipulated scope of work) in the past three years and also should submit a proof for the same (will upload satisfactory completion certificate).
5. A copy of tender document duly signed by the authorized signatory shall be uploaded as token of acceptance of terms and conditions and scope of work.
6. PAN number, GST number receipts are to be uploaded within the technical specification envelope.
7. The firms which have been **blacklisted by central/ State Government/ UT / Board/Corporation and Punjab Engineering College (Deemed to be University) are not eligible to quote**. Affidavit regarding non-blacklisting shall be submitted in physical form along with EMD. A copy of the same shall be uploaded.

b)Financial Bid: This is the final price quotation submitted by the bidder and shall be submitted online only in BOQ and it will be opened only of the firms who qualify the Technical bid.

(III) GENERAL TERMS AND CONDITIONS

1. The bid of the tender should be uploaded on the website portal of <https://etenders.chd.nic.in> by **12:00 noon on 11th October 2019** where the e-tender would be uploaded.
2. Rates should be quoted FOR Punjab Engineering College (Deemed to be University), Sector 12, Chandigarh and should include all freight charges, postage, packing, cartage duties and taxes. **GST should be indicated in proportion to the items in the tender with clear breakup.**
3. **Items numbered 1 to 16 can be deleted/vary in quantity during PECFest 2019 as per our requirements, and billing will be done as per actuals.**
4. **The bidder must have PAN, GST number copies of which are required to be attached with the bid. TDS shall be deducted as per IT rule.**
5. **EMD (Earnest Money Deposit)** for tender amounting to **Rs. 50,000** in shape of **Demand Draft Banker's Cheque/Fixed Deposit receipt/Bank Gaurantee from a commercial bank which shall remain valid for a period of 45 days beyond final bid validity period**, in favor of **"Director, PUNJAB ENGINEERING COLLEGE (DEEMED TO BE UNIVERSITY), SECTOR 12, CHANDIGARH."** The EMD of the unsuccessful bidders will be refunded within 24 hours of the allotment of the tender.
6. The successful bidder shall have to submit **Performance Security @ 5%** of total value of contract in the shape of Demand Draft/Fixed Deposit Receipt/Bank Gaurantee in favour of **"Director, PUNJAB ENGINEERING COLLEGE (DEEMED TO BE UNIVERSITY), SECTOR 12, CHANDIGARH"** within 2 days from the date of issuance of work order which shall remain valid for a period of 60 days beyond all contractual obligation. The EMD will be returned on receipt of performance security.
7. **Tender without requisite amount of EMD shall out rightly be rejected, and no tenderer is exempted from the EMD. In case of breach/withdrawal of tender, the EMD shall be forfeited.** An affidavit regarding non blacklisting shall be submitted as per annexure 2 duly attached by executive magistrate/ notary public.
8. **No advance payment will be made.** Payment will be released upon satisfactory receipt/inspection/installation of goods/material and on production of bill (in duplicate) in the name of Director, Punjab Engineering College (Deemed to be University), and Chandigarh.
9. **No sponsors that a bidder gets for cost accommodation will be entertained for the fest in regard to the tender.** The contractor cannot sublet assign the job specified to him to any other vendor.

10. The received bids will be opened as on 21st October, 2019 at 12:00 pm and date of opening of the Financial Bid of the qualified vendors will be informed later.
11. However, the Chairman PECFEST 2019 reserves the right to reject or scrap the tender without assigning any reason.
12. The full and final payment will be released only after handing over the recordings of all main stage events to **PECFest 2019 Chairman**.
13. Tender will be allotted to the lowest bidder considering the overall quoted rates.
14. A **verification check of the brand, quality and quantity** of the materials listed in the infrastructure requirements will be conducted for the lowest bidder.
15. The items may be provided as per Bill of Materials and the Technical Bid, giving the complete breakdown of the commercials that the bidder is providing (mentioned in the tender), enclosed as (**Annexure I**). The purchase order will be released as per actual requirement while current list is tentative.
16. The responsibility of the material supplied by the contract and the safety of persons deputed by him for the installation of materials etc. shall be solely of the bidder. Punjab Engineering College (Deemed to be University), Chandigarh shall not in any way be liable/ responsible for any loss/damage to the material/life on any account, if any, occurred during PECFest days.
17. In case, any bidder after successful bid stepped back in any circumstances then his/her EMD will be forfeited and action may be taken against the bidder.
18. In case of any default Punjab Engineering College (Deemed to be University), sector-12, Chandigarh will have the right to arrange the material at the risk and cost of vendor from any other source and the cost shall be deducted from the final payment with 20% penalty.
19. The main stage along with sound and lighting arrangements should be ready by 3pm during all Fest days or else a penalty of Rs. 4,000 per hour till 6pm and entire day's cost after 6pm would be levied upon the contractor (to be deducted at the time of the payment).
20. All the stalls having facility of lighting and electricity should be ready by 8am of first day of the Fest or else a penalty of Rs. 4,000 per hour till 12pm and entire day's cost would be levied upon the contractor (to be deducted at the time of the payment).
21. No conditional/optional bid shall be accepted and Bidders shall not be permitted to alter or modify their bids after expiry of last date for receipt of Bids.

22. Chairman PECFest reserves right to vary scope of work at the time of placement of Supply Order/Signing of Contract.
23. Printed terms and conditions of bidder shall not be considered as forming part of their bids.
24. All disputes are subject to **Chandigarh jurisdiction only.**
25. Bids received after due date/time will not be accepted. In case of any technical issues regarding the e-tender bid, the vendor can contact landline number 0172-2706877, 0172-2753912 on any working day between 9:00 a.m. to 5:00 p.m.
26. The firm is entirely responsible for any damage or loss occurred in transit. The firm will lodge all the complaints regarding damage occurred in transit and shall bear all expenses. No claim for damage due to natural occurrences.
27. In a tender, either the Indian agent on behalf of the Principal/ OEM or Principal/ OEM itself can bid but both cannot bid simultaneously for the same item/ product in the same tender.
28. If an agent submits bid on behalf of the Principal/ OEM the same agent shall not submit a bid on behalf of another Principal/ OEM in the same tender for the same item/ product.
29. In case, the date of receipt/opening of tender is declared or happens to be a public holiday, the tenders will be received/ opened on the next working day at the stipulated time.
30. Bidder who will **quote all the items as specified in the tender will be eligible** for this tender, any bid which have partial quote for the specific job only or supply of only few items will be rejected.
31. Confidentiality of the tender should be maintained.
32. All the documents uploaded should be duly signed and sealed/stamped by the bidder.
33. **Items can be removed or decreased as per requirements on particular day and particular situation. Bill would be charged for used or utilised items only.**
34. **The vender which gets the infrastructure tender for PECFEST 2019 would require providing assurance of the quality of materials/items provided on a legal stamp paper.**

35. If during operation at any time, the Gen-sets stop working and cause hindrance in the normal running of the function, penalty of **5 times the Gen-sets cost** will be applied and the amount will be charged on the selected vender as fine.
36. If during operation (primarily 7pm-11pm) night function, the stage, barricading or any other construct breaks down or causes hampering to normal function, **20 % of the Total tender amount** will be charged as penalty to the selected vendor.
37. The responsibility of the material supplied by the contractor and the safety of persons deputed by him shall be solely of the bidder. Punjab Engineering College (Deemed to be University), Chandigarh shall not be in any way be liable/responsible for any loss/damage to the material/life on any account, if any, occurred during PECFest.
38. The successful bidder would be required to submit 3 different stage designs, one of which would be selected by the PECFest committee 2019.
