- 1. Tenderers are advised to study all technical and commercial aspects, instructions, forms, terms and specifications carefully in the tender document. Failure to furnish all information required in the tender document or submission of a bid not substantially responsive to the tender document in every respect will be at the tenderers risk and may result in the rejection of the bid.
- 2. The tenderer should indicate specifically the Basic Price, Taxes/Excise duty, other duties (if any) and levies chargeable. No additional information will be entertained after due date.
- 3. The tenderers should give their quote in Indian currency only keeping in mind that our institute (i.e. Punjab Engineering College (Deemed to be University)) is exempted from the payment of custom and excise duty. Only custom & excise duty exemption certificate will be issued. The bidder should offer the landing price (FOR, Punjab Engineering College (Deemed to be University, Chandigarh) which must include transportation, packing, loading unloading, any kind of taxes including GST, entry tax etc. No separate claim will be entertained under any circumstances.
- 4. The Bidders shall have to submit their Bids online in Electronic Format with Digital Signatures.
