- 4. There should not be any over writing and cutting/erasing etc. on the bid sheet. If inevitable; the same should be authenticated by a person authorized by the bidding firm.
- 5. The bidder should submit a consolidated price for all the items in Table I for AMC for a period of one year.
- The AMC contract will be awarded for a period of one year, however the institute reserves the right to review the contract before the expiry period of 12 months depending upon the need for continuity.
- 7. The institute may extend the contract further after the expiry of contract for a maximum period of one more year or on quarterly basis on the approved rates and on the same terms and conditions.
