- 3. The firm who has been blacklisted by Center/State Govt/UT/Boards /Corporations/ any Government authority / PEC are not eligible for the quote. An affidavit of non-black listing as per Annexure 'A ' shall be submitted duly attested by Notary public/Executive Magistrate.
- 4. No advance payment will be made,
- 5. All the rates will be FOR, PEC, Chandigarh.
- 6. The institute being a premier Education and Research Institute funded by Chandigarh Administration, discounts as applicable to Research Institute/Educational Institutes may be provided in the quotation.
- 7. The bidders shall not be allowed to change, alter or modify the bids after expiry of the deadlines for the receipts of bids.
- 8. The firm is entirely responsible for any damage or losses occurred to the material in the transit. The firm will lodge all complaints regarding the damage occurred in the transit & shall bear all expenses.
- In a tender, either Indian agent on behalf of the Principal/OEM or Principal OEM itself can bid, but both cannot bid simultaneously for the same tender for the same item/ product.
