1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

Additional Term and Conditions

1. Eligibility Criteria for Bidders:

The bidders should fulfill the following requirements: -

a) The bidder should not have been blacklisted/debarred by any Govt. /Statutory bodies/ autonomous organization prosecuted by any court of law. The bidder should submit the affidavit as per annexure- A. **The affidavit submitted other than the prescribed performa will not be considered.**

b) Past experience: The bidder should have experience of having successfully completed similar works during last seven years ending last day of the month previous to the one in which applications are invited.

The bidder should have supplied the manpower during last seven years as follows:

- One work of providing manpower of 28 nos./ One completed work costing of Rs. 1,01,79,486/- (Each)

Or

- Two works of providing manpower of 18 nos./ Two completed works costing of Rs. 63,62,179/- (Each)

Or

- Three works of providing manpower of 14 nos./ Three completed works costing of Rs. 50,89,743/- (Each)

Note:

- i. The works of atleast one-year duration will only be considered. Bidder should submit the completion certificate of the work experience from the client department.
 - ii. Similar works means providing manpower to any Govt. Dept./ Autonomous body/ Govt. Institute/ Govt. University/ Public Sector Undertaking of Govt. of India or any other State Govt. or local bodies/ Municipalities etc. during the last 7 years
- c) The bidder should have registered office address in tricity (Chandigarh, Panchkula & Mohali). Registered address with statutory proof i.e. GST, EPF, ESI or any other Govt. document showing the tricity address will only be considered. **Rent agreement as proof of registered address in tricity will not be considered.**
 - d) The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March 2025 should be **03 crores.**
 - e) The Firm should have registration with EPFO, ESIC, GST and other relevant Departments.
 - f) The firm should have to submit the EMD @ 2 % of the estimated bid value. The EMD in original shall be submitted in the shape of demand draft/ FDR in favour of Director, Punjab Engineering College. The EMD shall be reached in the Estate Office, Punjab Engineering College, Sector-12, Chandigarh on or before the opening of technical bids.

Note: - **Technical bids will be opened for the bidders who have submitted the EMD as required, before the opening of technical bids. For availing exemption benefit, the firm should be registered in the relevant category.**
- **Exemption will be given to the MSME/ verified startups in turnover and EMD only.**

2.The successful bidder shall have to submit the performance guarantee @ 5% of the tendered amount before starting of contract.

3. The successful bidder must adhere the guidelines issued by the Chandigarh Administration vide no. 19/C2/2021/PEO/GeM/885, dated 25.10.2021.
4. The contractor shall make payment of wages to the manpower on the basis of the existing minimum wages (DC Rates) applicable in Chandigarh. As and when the rates are revised, the difference in wages shall be paid to the manpower.

5. Duration of Contract: The contract shall be initially for 01 (One) year. However, the contract may be renewed upto three years (to be renewed annually, if found satisfactory) on the basis of satisfactory performance and mutually agreed upon unaltered terms and conditions. In case of unsatisfactory performance, the contract will be terminated by giving one-month notice.

6. The contractor shall have to provide the manpower as per annexure-B. The manpower will be deployed for 06 days in a week.

7. **The contractor shall provide proper uniform to every personnel deployed by them in the Institute Campus at its own cost and expenses with their logo.** Services charges may be quoted accordingly. Nothing extra shall be paid in addition to the rates quoted.

1. Scope of Sanitation & Housekeeping Services may include

- a) Housekeeping services including sweeping, dusting, removal of spider webs, cleaning of window panes, cleaning and mopping of floors of auditorium, seminar rooms, common rooms (boys/ girls), drawing halls, lecture halls, tutorial rooms, labs, offices, verandas, corridors, stair halls, and toilets (by mopping/ washing with water, detergents/ disinfectants, etc.), etc. throughout the PEC campus.

NOTE:

- i. Suitable number of female cleaners should be deployed for taking care of cleaning works of ladies toilets and ladies rooms. Only male workers should be deployed to clean the Gent's toilets in the premises. The toilets should be cleaned every day with utmost care.

However in case if any condition specified in सामान्य नियम और शर्तें/General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में

भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
