Distinguished fellowship/ Visiting Faculty of International/ global rated Institution/ University
Publication in SCI Journals
Externally sponsored project beyond Rs. 30 lacs
Consultancy beyond Rs. 10 lacs for a single project except for testing of samples
Feedback from various stakeholders
Book writing/ editing of reputed journal/ articles in news papers, magazines and periodicals
Innovation in Pedagogy
Contribution in strengthening of laboratories, curriculum design, project work, student activities, Departmental activities and Institution activities

B. Alumni:

Alumni who has contributed to the Institution
Alumni who has excelled in their area of career
Alumni who has created a niche in society at young age (less than 40 years at time of consideration)
Based on above parameters the committee may evolve suitable guidelines for making recommendations

C. Staff: 02 (01 Technical & 01 Ministerial)

Best Performer (Technical)
Best Performer (Ministerial)
For Technical staff, contribution in strengthening of laboratories, curriculum design, project work, student activities, Departmental activities and Institution activities may be considered. For Ministerial staff the parameters as indicated in the new pattern ACR Proforma may be considered.


